Using natural gas for construction heat, allows your project to stay on schedule and budget. Natural gas heaters are easy to install and provide significant cost savings compared to propane heaters. Whether you use an installed furnace or rent a temporary construction heater, natural gas is an efficient and cost-effective choice.

Builders are required to contact Enbridge to have Enbridge activate the meter set for construction heat purposes. As part of Enbridge's process, builders are required to pay an inspection charge of \$70 + HST to activate natural gas for construction heat. This fee includes a site visit to assess your installation and determine whether it meets the criteria set forth in the Enbridge guidelines for construction heat.
